## **Processing History**

This collection was processed and the finding aid written by Alice Griffin, 2015. From March to April 2024, Olivia Newsome made significant edits to the overall collection.

During March-April 2024, Olivia Newsome moved the Committee to Meet the Needs of the Disabled (CMND)/Barnard Design for Access (BDA); Committee on Institutional Assessment; Judicial Council to the record group BC19 (committees).

In April 2024, Olivia Newsome moved the following collections to BC06 and created new collections: Advisory Committee on Appointments, Tenure, and Promotions (ATP); BLAIS Advisory Committee; Faculty Budget and Planning Committee (FBPC); Faculty Governance and Procedures Committee (FGPC); Faculty Finance and Resource Committee (FFRC); Committee on Committees; Faculty Executive Committee (FEC).

In April 2024, Olivia Newsome moved the following collections to BCO6.03: Committee on Courses of Study; Curriculum Committee; Curriculum Review Committee; Subcommittee on Advanced Placement and Advanced Standing; Subcommittee on Administrative Problems. Additionally, Olivia Newsome moved BC19.13, BC19.06, BC19.08, BC19.04, BC19.10; Committee on Scholarships; Committee on Foreign Language Requirements; Committee on the Schedule of Hours; Committee on Committee on Advice to New Students and Committee on Students' Programs; Committee on Transfers from its record group BC19 (Committees) to BC06.01 (Faculty Committees) to reflect that it is a faculty committee.

In April 2024, Olivia Newsome moved the Ad-Hoc Summer School Committee from BC06.03 to BC06.01 to reflect that it is ad-hoc faculty committee. Olivia Newsome also moved the Committee on Foreign Language Requirements to BC06.01 because it is unrelated to COI. Olivia Newsome also moved the Committee on the Developing Student from BC05.02 since it is a faculty committee. Additionally, Olivia Newsome moved the Barnard Council file to BC05.07, Development Office, since it was not a faculty committee and administered by that office.

From June 2024-August 2024, undergraduate associates Ruben Carter and Gabriela Ogando Ortega rehoused the majority of the collection and added historical notes to most of the committees.

#### **Historical Summary**

Established in 1966, the Ad Hoc Committee on the Curriculum was tasked with creating factual reports on the state of the curriculum at Barnard and making recommendations accordingly. Reports included statistics on students' academic performance, distribution of majors, alum pathways after graduation, and surveys of curricular models of comparable institutions. The Ad Hoc Committee on the Curriculum was expressly created to continue work done by the Committee on Instruction and faculty.

Ad-Hoc Summer School Committee, 1996-1997

#### **Scope and Contents**

This folder contains correspondence and the final report of the Ad-Hoc Summer School Committee.

#### **Historical Summary**

The Ad Hoc Summer School Committee met from 1996 to 1997 and was tasked with reviewing policies around summer school credit and submitting a proposal of recommendations to the Committee on Instruction. Chaired by the Registrar, the committee included members of the Committee on Instruction, the Committee on Programs and Academic Standing, and department chairs. The committee's 1997 proposal included recommendations to change the credit approval form, lower the minimum grade needed for credit, and include summer school grades in cumulative GPA. In records, the committee is also called the Ad Hoc Committee on Summer School Policies and Procedures.

Advisory Committee on Educational Policy, 1922-1930

#### Scope and Contents

This folder contains the meeting minutes of the Advisory Committee on Educational Policy.

#### **Historical Summary**

The Advisory Committee on Educational Policy oversaw many of the university's academic functions, including the appointment and promotion of professors, the creation of research institutes, the approval of departmental budgets, and the creation of new degrees or academic programs. Archivist assumes the Committee met from 1922 to 1970.

Barnard-Columbia Joint Committee on Cooperation, 1970

This folder contains the reports of the Barnard-Columbia Joint Committee on Cooperation.

#### **Historical Summary**

The Barnard-Columbia Joint Committee on Cooperation was reestablished in 1969 by the Committees on Instruction of the two institutions after a dormancy of several years. The Committee was tasked with making recommendations to increase cooperation between the two colleges without reducing either's autonomy. Proposals with recommendations were sent to the Committee on Instruction and discussed topics like partial coeducation, shared extracurricular and social activities, and joint housing. The Joint Committee on Cooperation was composed of administrators, professors, and students from both Barnard and Columbia College.

Catalogue Committee, 1954

#### **Scope and Contents**

This folder contains the meeting minutes, report, and memorandum of the Catalogue Committee.

#### **Historical Summary**

The Catalogue Committee was tasked with making recommendations to the president and academic departments about improving Barnard's course catalog for prospective and enrolled students. In 1954, three subcommittees of the Catalogue Committee were created, each focusing on a different aspect of the course catalog: content, typography, and presentation. In 1954, recommendations included a request to the President to write a statement defining the aims of the college and a restructuring of department statements.

Committee on Advice to New Students and Committee on Students' Programs, 1923-1924

#### **Historical Summary**

"The Committee on Advice to New Students met only in 1923 where they discussed what information incoming and current Freshman should be provided in the Bulletin as well as when and how they should meet their advisers.

The Committee on Students' Programs is also bound within the same book and ran from 1923-1924 including the same faculty members from The Committee on Advice to New Students. This committee discussed all student programming needs including class

registration efforts and general procedures for student programming."

Committee on College Operations, 1952-1954

#### **Scope and Contents**

This folder contains the reports, correspondence, memoranda, and meeting minutes of the Committee on College Operations.

#### **Historical Summary**

Established in 1952, the Committee for College Operations was tasked with conducting studies and gathering quantitative data of use to report to other committees and academic departments. The Committee collected information on the distribution of classes students took within majors, class size, additional space for offices and laboratories, and class lengths, among other things. In records, the Committee is also titled "Committee for College Operations Analysis" and "Committee for College Operations Research." Archivist assumes the Committee ran until 1954.

Committee on the Deanship, 1946

#### **Scope and Contents**

This folder contains a report of the Committee on the Deanship.

#### **Historical Summary**

The Faculty Committee on the Deanship worked in tandem with the Trustee Committee on the Deanship to select a new dean for Barnard College. The Committee assessed candidates' qualifications—reviewed candidate files, visited schools and colleges, conducted interviews, etc. A 1946 report narrowed a list of 50 candidates for deanship to five, of which "Mrs. Rustin McIntosh" was one, who took office in June 1947.

Committee on the Developing Student, 1968-1969

#### **Scope and Contents**

This folder contains meeting minutes, correspondence, report drafts, supporting documentation, and a memorandum of the Committee on the Developing Student.

#### **Historical Summary**

The Committee on the Developing Student was appointed in the Spring of 1968 and was tasked with evaluating the then-current "special students"

program. At the time, "special students" were defined as "disadvantaged" admits with promising academic potential despite low college board scores. In the spring of 1964, Barnard admissions made two distinct decisions- to admit more "special students" as well as more Black students. In the fall 1964 semester, the first group of "special students were admitted along with 18 Black students. A few years later, in May 1968, the Committee on the Developing Student started meeting, and in December 1968, produced their first draft proposal reimagining the "special students" program as Barnard's Program for Developing Students (PDS). In original drafts, PDS was imagined to be an "expansion and revision" of Barnard's existing program for "culturally disadvantaged" (and in later drafts "educationally disadvantaged") students. The proposal recommended the admission of 50 PDS students each year with a substantial amount from the NYC metropolitan area.

During the proposal drafting process, the Committee on the Developing Student faced pressures from within the student body. In February of 1969, the recently formed Barnard Organization of Soul Sisters (BOSS) directed 10 demands at President Peterson—one of which pertained to the "special students" program. Specifically, BOSS criticized Barnard for the lack of material support given to "special students" after their admission to the college. After numerous proposal drafts, PDS was approved at a Faculty meeting on April 21st, 1969. The program officially began in the fall of 1969 with the admission of 29 PDS students and the appointment of a new program director. In records, the Committee is also called the Committee on Disadvantaged Students and the Committee on Special Students.

Committee on Foreign Language Requirements, 1911-1963

#### Biographical / Historical

The Committee on Foreign Language Requirements met from 1933 to 1947. They discussed the Barnard College foreign language requirement.

This folder contains correspondence and a report of the Committee to Foster Faculty Research.

#### **Historical Summary**

Appointed by Dean Millicent McIntosh in March of 1950, the Committee to Foster Faculty Research was tasked to evaluating the challenges surrounding Faculty research and how to better encourage it. After conducting a questionnaire to gauge the Faculty's opinions, the Committee suggested that the College reduces the teaching, advising, and committees obligations; sets up a fund for Faculty grants of \$12,000 a year; grants leaves of absence to members of the teaching staff, among others.

Committee on the Future of the College, 1951

#### **Scope and Contents**

These folders contains reports and correspondence of the Committee on the Future of the College.

#### **Historical Summary**

The Future of the College Committee, also called the Size of the College Committee, was appointed by Dean Millicent McIntosh in 1947, with the goal of measuring and evaluating the possible expansion of the College. Created in response of growing trends in Higher Education, the Committee--initially composed of Faculty and later becoming Faculty-Trustees--evaluated the extent to which the school could increase its student population, considering questions on Financial Aid, admissions standards, teaching space, among others.It ran through 1964.

Committee on Missions and Goals report, 1970

#### **Scope and Contents**

This folder contains a report of the Committee on Missions and Goals.

#### **Historical Summary**

The Committee on Missions and Goals was in charge of establishing what the boundaries of Barnard, as a "Small Liberal Arts College for women", should be. The Committee proposed the student population to be capped at 2,000, argued against Co-Ed at the College, and suggested curricular changes to strengthen the "Liberal Arts College" identity. There is a single report from 1970.

Committee on the Schedule of Hours, 1920-1934

#### **Historical Summary**

The Committee on Schedule of Hours met from 1920-1935. They discussed scheduling conflicts of Barnard College courses interdepartmentally.

#### **Historical Summary**

The Committee on Scholarship was a standing committee created in 1903. They oversaw which students were awarded scholarships. The archivist guesses that the Committee on Scholarship ran from 1903-1955.

#### **Biographical / Historical**

President's Advisory Committee on Tenure Practices, 1980

#### **Scope and Content Summary**

This folder contains the meeting minutes, correpsondence, research files, memoranda, and position papers created by members of the President's Advisory Committee on Tenure Practices in 1980.

#### **Historical Summary**

Appointed by former president Ellen Futter in 1980, the President's Advisory Committee on Tenure Practices was asked to review the procedures followed in the tenuring of BC faculty; assess the fairness, appropriateness, among others, of the procedures followed; and make recommendations to Barnard's acting president. The Committee was chaired by Professor Emeritus Steve Saulnier and it included three other active Faculty members.

Tenure Process Review Committee (TPRC), 2002-2004

#### **Scope and Contents**

These folders contain the report, meeting minutes, working paper, correspondence, and supporting documentation of the Tenure Review Process Committee.

#### **Historical Summary**

The Tenure Process Review Committee (TPRC) was established in Spring 2002 at the suggestion of faculty who expressed anger towards the administration for not addressing Barnard's unique tenure process. Comprised of 10 professors from different departments, the committee believed that the administration was to blame for the low rate of tenured faculty at Barnard. Unlike other institutions, Barnard's tenure process required approval from a Columbia ad hoc committee appointed by Columbia's provost's office. In February 2004, the committee published a report based on faculty input gathered from a questionnaire sent out the previous year. In the following months, the report was presented to the Advisory Committee on Appointments, Tenure, and Promotions (ATP), the former president Judith Shapiro, and members of the Board of Trustees. In Fall 2004, the ATP changed internal committee

procedures in response some suggestions made by the TPRC.

Thursday Noon Meetings, 1967-1987

#### **Scope and Contents**

These folders contain the correspondence; purpose, procedures, and finances; and the schedules of the Thursday Noon Meetings.

#### **Historical Summary**

The Thursday Noon Meetings were a weekly program carried out in College Parlor (now Sulzberger Parlor) during the academic year, in which students, faculty, and guest speakers would convene to discuss problems of "philosophical, moral, or religious significance". The program started in 1953, created by then President McIntosh and several faculty members. The meetings had an outlined structure: the guest speaker of the week introduces a discussion of their choice--with a talk of no longer than thirty minutes--followed by a lunch break, and finished with a Q&A section. Archivist assumes the program ran through 1987 and was mostly managed by Professor Serge Gavronsky.
