### **Historical Note**

Organized at the request of the Executive Committee of the Faculty, the Fact Finding Commission was composed of five members and chaired by Harvard law professor Archibald Cox. The Cox Commission, as it became known, was given the mandate to establish a chronology of events leading up to and including the Columbia crisis, and to inquire into the underlying causes of those events. The Commission held twenty-one days of hearings starting in May 1968, heard testimony from seventy-nine witnesses, and compiled 3,790 pages of transcript. The report, published in a paperback edition on September 26, 1968, stressed the lack of effective channels of communication between administration, faculty, and students, and endorsed implicitly the Executive Committee's idea for a representative University Senate.

### Summary

This collection consists of the work conducted by the Fact Finding Commission appointed to investigate the disturbances at Columbia in April and May 1968.
