She organized

and participated in conferences and other forums on Islam, gender equity, conflict resolution, and cross-cultural understanding in New York City and around the world, and served as a board member and/or consultant to numerous interfaith organizations and documentary projects on the Muslim American experience. Aisha al-Adawiya is also an organizer for and speaker on social justice issues including the domestic and global war on terror and its effect on Muslims and the Global South, racism and anti-Blackness, Palestine, anti-war, human rights, and natural disaster relief.
