The documents primarily include reports of the deliberations of the commission, memoranda prepared by its members, statements by informants at meetings and interviews, and drafts for the books which it eventually published. The Office papers consist of personal notes, correspondence, and clippings. In addition there are notes on the history of the Federal Communications Commission, 1927-1946, and some related notes and other materials.
