Editor. Longwell was an editor at Doubleday and supervised the publication of works of Edna Ferber, Ellen Glasgow, and other writers. In 1934, he joined Time, Inc., where he was one of founding editors of LIFE, and chairman of the board of editors from 1946 until his retirement in 1954.

Hart Benton, the Duke and Duchess of Windsor, Christopher Morley, and H.L. Mencken as well as artists such as Tom Lea and Peter Hurd. Also, correspondence and memoranda dealing with the Time-Life organization, among them an extensive series of letters from Henry R. Luce and various editors of the magazines.
