Physician, President of the College of Physicians and Surgeons, 1826-1831, Trustee of Columbia College, 1824-1831, alumnus of Columbia College, 1804. Watts was graduated from Edinburgh University, Medical Faculties in 1809 and served as an army surgeon during the War of 1812. He was John Jay's family physician.
