The Correspondence and minute book of the NYCDC pertains to its membership, organizational structure and official incorporation. Cataloged correspondents include Senator John F. Kennedy and Mario Cuomo. Includes miscellaneous campaign literature. Arranged Chronologically, then alphabetically by topic.
