The process provides an opportunity for critical self-review on a recurring basis and for reevaluating long-range planning assumptions and goals. By providing a means for reaching collective judgment on the strengths and weaknesses of a program, its comparative advantages, and its future opportunities and challenges, the review process contributes to achieving and maintaining the excellence of programs across the Arts and Sciences.
