Series II: Committee on International Development (CID), 1985-1993

Scope and Contents

The Committee on International Development was created in the 1980s by AIUSA in response to a need for development in some sections of AIUSA. CID managed three funds and was tasked with reviewing proposals and allocating funds to specific projects that promoted intersectional cooperation, enhanced the initiating section's capacity for self-sustaining development, increased a section's ability to do human rights work in its own community, and promote HR awareness. The series documents the creation and goals of CID as well as its activity. Documents include outlines of CID's goals and plans, criteria for reviewing proposals, financial information, and information on specific projects.
